

Romania said a Russian drone violated its airspace, becoming the second NATO nation to report such an intrusion.

Chinese and US officials launched trade negotiations in Madrid this Sunday (September 14). US Treasury Secretary Scott Bessent and senior Chinese officials, including Vice Premier He Lifeng, will discuss economic and trade issues and TikTok. Both delegations will remain in Madrid until Wednesday.

The historic pay package made by board of directors of TSLA to Elon Musk surely is one of the hottest topics of the market recently. First of all, the writer needs to make some supplements for I had not asked the AI to show them.

Similar package with low level had been raised in Delaware but banned by the court because a small shareholder raised a court case that the package was harmful to small shareholders. Therefore, the headquarter of Tesla moved to Texas. In this state, if any shareholders wished to have any objections to the plan made by board of directors, must be up to 3% of share holding or else the court would not accept it. The whole project is divided into 12 tranches. Honestly, not all tranches can come true on time. Practically, some stages can hit the target and some may be slower and left behind. Obviously, he wants the first stage can be done on time. He wants his first shot can be brilliant and splendid. TSLA shown a Double-double bottom, or Complexed W-shape with 4 bottoms. Then went up but other stocks rocketed up and it is in hibernation. The pattern was in symmetrical triangle and later changed to upward channel. From hibernation to half awakening and half sleeping. Until the day before Employment Report, it is the last train to catch for buying.

So those that bought before Employment Report can enjoy the rise of 2 big white candlesticks and the jumping gap of Monday. Is it too risky to chase? Sure! That's why I said should lock up stocks bought from March to August.
